- R. Neate noted there is a work backlog. The backlog is more prevalent on the elevating devices side, mostly with periodic inspections. TSSA is looking at changing the ways periodic inspections on inflatables are completed. Operators of inflatables will be permitted to begin operation ahead of periodic inspections because of the low risks associated with these devices.
- S. Silva expressed gratitude for the industry's patience and professionalism during the TSSA strike.
- M. Cruz thanked TSSA for its professionalism, particularly considering the media interest in the strike and its impact on amusement parks.

### 7. Accreditation of mechanics

- P. Switzer spoke to this item and noted that three relevant documents were circulated as part of the meeting package, including a gap analysis. He provided background on consideration on adding time toward an AD mechanic licence for employees that have prior training and experience. The first objective was to compare the certificate requirements with industrial millwright requirements. A gap analysis was completed.
- S. Silva noted that TSSA will review the recommendation and move it forward. R. Neate said TSSA is aligned directionally with this idea. His program will connect with TSSA training and certification staff and will provide an update at the next meeting.

Action: R. Neate to provide an update at the next advisory council meeting on mechanic accreditation.

### 8. Council Administration

  - O. Silva-Dias spoke to the item. B. Carter has decided not to renew his membership. The other three have yet to reply. [Following meeting, V. Brennan and D. Hore indicated they will renew].

## 9. ASTM Update

J. Javier indicated that since the 2021 edition of the Amusement Devices Code Adoption Document (CAD) amendments there are no updates. In the coming year there will be new standards that TSSA will look to adopt in the Canadian standard so that the CAD can be amended. S. Silva noted that the F770 Standard Practice for Ownership, Operation, Maintenance, and Inspection of Amusement Rides and Devices has a new update that comes into effect Dec. 2022.
