5. Chair's Update

The Chair provided an update of recent activities.

The Chair attended the ASTM-F24 meeting in Denver on October 19. TSSA had noted, as part of the Ontario update, that it is considering adopting the ASTM life cycle and acceleration measurements for waterslide standards. Upcoming standards and ballots will include a ballot to pull in other ride-specific and ride-supporting standards, a ballot to clean up references to other standards, and an administrative change to move the table to the end of the standard.

The next ASTM meetings will be held in February 2024 in Louisville, KY and potentially in April 2024 at SafeConnect B.C., PNE, Vancouver.

The TSSA-NAARSO safety seminar will be held in April 2024 along with an ASTM meeting. Council members are welcome to attend.

The Chair attended the IAAPA Expo. At the Canadian breakfast S. Silva and A. Tanzer were recognized for their standards and safety work.

The Canadian F2783 standard model will be used as a proposed framework for the Australian standard for amusement rides and devices.

The Chair attended the Canadian Association of Fairs and Exhibitions conference. Scooter Korek, North America Midway Entertainment, was inducted into the Honour Roll Hall of Fame for over 50 years of dedicated service.

The Chair is currently attending the International Association of Fairs and Exhibition Conference in Salt Lake City, UT.
